Blue Ridge Mountain EMC Annual Meeting Scheduled for Sept. 26

YOUNG HARRIS, Ga. — Blue Ridge Mountain EMC will hold its Annual Meeting on Thursday, Sept. 26, at the BRMEMC Headquarters in Young Harris, Ga. The business meeting will begin promptly at 3 p.m. All members are invited to attend.

This year is an uncontested election, but members are encouraged to vote in order to achieve a quorum. Plus, all voters will be entered to win one of three cash prizes that will be awarded on Monday, Sept. 30. Votes may be cast online at www.directvote.net/brmemc, in person at the Annual Meeting or by mail. Online voting begins Aug. 23 and ends at midnight on Sept. 24. Members will need their BRMEMC membership number and election passcode to vote online. This information can be found on the front of the August and September 2019 electric bills or by calling Survey and Ballot at (866) 909-3549. Voting at the Annual Meeting begins at 1 p.m. at the headquarters of BRMEMC in Young Harris, Ga., and ends at 3 p.m. Paper ballots are available upon request from Survey and Ballot by calling (866) 909-3549. Mailed ballots must be received by Sept. 24 and should not be returned to BRMEMC, but rather members should follow the mailing instructions printed on the ballot.

Three members of the Board of Directors terms expire with the Annual Meeting this year. The Nominating Committee has nominated the following members for re-election to a three-year term: Cory Payne, Clay County, N.C., Ray Cook, Cherokee County, N.C., and Gene Mason, Union County, Ga. There were no nominations made by petition.

This year marks the 81st Annual Meeting. General Manager Jeremy Nelms will welcome members, present the executive summary for the 2018 calendar year and share any upcoming news and events.

“I look forward to having the Annual Meeting at the BRMEMC headquarters this year,” said General Manager Nelms. “I’m hopeful members will take advantage of this opportunity to vote and attend the meeting right here at their electric co-op.”
